**SUMMARY:** The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a revised request submitted by Community College Prep Public Charter School (CC Prep PCS) on April 4, 2018 to operate at two additional facilities effective for SY 2018-2019.

CC Prep PCS is currently in its fifth year of operation serving adult students at a single campus with two separate facilities. Effective for SY 2018-2019 and beyond, the school plans to operate at two additional facilities located at 1) Hope Village, 2844 Langston Pl. SE, and 2) Department of Employment Services – Infrastructure Academy, 2330 Pomeroy Road SE. If approved, this amendment will allow the school to pursue additional community partnerships and serve more adult students in the District.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its campus locations.
