

Notice of Charter Reviews and Renewals: Multiple Schools – Lee Montessori PCS Meridian PCS National Collegiate Prep PCHS Perry Street Prep PCS Roots PCS . ACTION: Open for Public Comment PUBLIC COMMENT ACCEPTED UNTIL: December 17, 2018

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comments on the DC public charter schools (PCS) listed below, which are up for a charter review on Monday, December 17, 2018. Pending DC PCSB staff's analysis, the Board may elect to do one of the following for each school: 1) Continue the school's charter without conditions, 2) Conditionally continue the school's charter by imposing annual or interim targets it must meet, **or** 3) Commence charter revocation proceedings.

1. Lee Montessori PCS:

Lee Montessori PCS is up for its 5-year charter review. The school currently operates a single campus in Ward 5 where it serves students in grades prekindergarten-3 (PK3) through five, and it will add sixth grade next school year. Its mission is to "create a peaceful, multi-age learning environment for preschool and elementary age children that fosters the physical, social, emotional and academic growth and development of students and produces life-long learners using the materials and philosophy developed by Maria Montessori and furthered by the Association Montessori Internationale."

2. Meridian PCS:

Meridian PCS is up for its 20-year charter review. The school currently operates as a single campus with two facilities in Ward I where it serves students in grades PK3-8. Its mission is as follows: "Meridian Public Charter School is a rigorous Pre-K to 8th grade school, which academically and socially prepares its diverse student population to be successful in an increasingly global and technology-based society."

3. National Collegiate Prep PCHS:

National Collegiate Prep PCHS is up for its 10-year charter review. The school currently operates as a single campus in Ward 8 where it serves students in grades 9-12. Its mission is to "offer a rigorous standards-based college preparatory curriculum, to maximize our students' academic achievement, provide an interdisciplinary curriculum that combines international studies themes that would offer an opportunity for an International Baccalaureate (IB) education, and prepare our students to be self-directed, lifelong learners equipped to be engaged citizens of their school, community, country, and world."

4. Perry Street Prep PCS:

Perry Street Prep PCS is up for its 20-Year charter review. The school currently operates a single campus in Ward 5 where it serves students in grades PK3-8. Its mission is as follows: "Perry Street Prep is a community of diverse learners that builds relationships with families and empowers students to be college-ready and to thrive in a global society."

5. <u>Roots PCS</u>:

Roots PCS is up for its 20-Year charter review. The school currently operates a single campus with two facilities in Ward 4 where it serves students in grades PK3-5. Its mission is to "offer a culturally relevant (African-Centered) and academically stimulating curriculum. We seek to promote and secure the connection of mother Africa within our children; Prepare students to break the chains of psychological conditioning that attempts to keep them powerless in all phases of society; Provide students with a strong African-Centered learning environment; Guide students toward academic excellence, exemplary character, and social responsibility; Encourage success leading to self-reliance and economical, social, and political contributions to society."

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., the DC Public Charter School Board (DC PCSB) is required to review each DC charter school's performance at least once every five years, and if a school wants to continue operating beyond its original 15-year charter it must apply to DC PCSB in its fifteenth year of operation to renew its charter for another 15-year term.
