

## Notice of Petition to Amend Charter: Expansion Request – **Creative Minds Public Charter School**

**ACTION: Open for Public Comment** 

PUBLIC COMMENT ACCEPTED UNTIL: May 11, 2015

**SUMMARY**: The District of Columbia Public Charter School Board ("PCSB") announces an opportunity for the public to submit comment on an expansion request submitted by Creative Minds Public Charter School ("Creative Minds PCS") on March 6, 2015 to amend its charter to add a middle school program.

Creative Minds PCS is currently in its third year of operation, serving students in grades prekindergarten-3 through fourth. The school currently operates at a single campus on 16th Street, NW in Ward 1 but will be moving to a new facility at the Armed Forces Retirement Home in Ward 5. Creative Minds PCS proposes to expand its elementary school to operate a middle school in order to serve students through eighth grade, growing one grade per year through 2018-19. They will continue to use an internationally-focused and inclusive curriculum.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes an expansion request.
