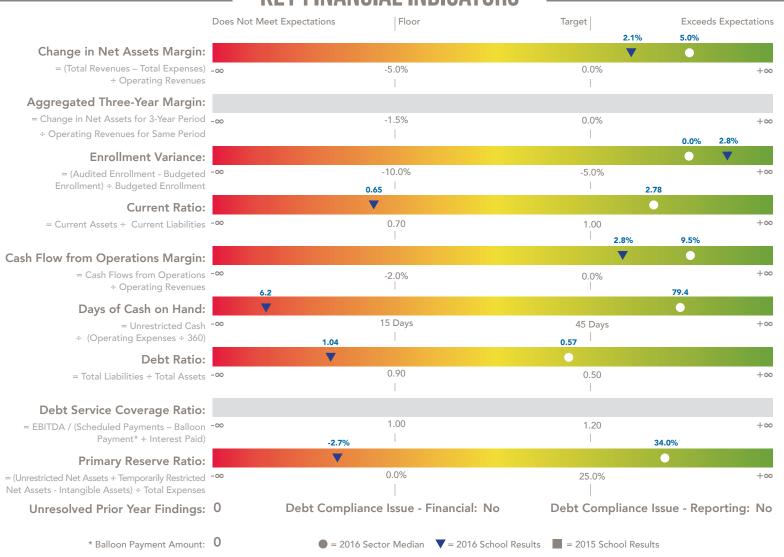

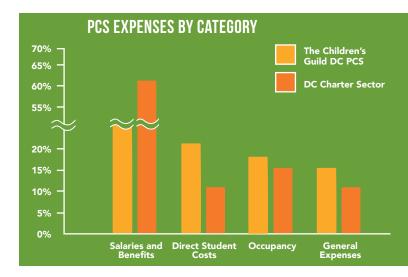


Comments from the School

The first years of operations are geared towards investment in people, facilities, and systems. As the program matures, assets will be generated to fully fund operations and repay debts while creating an operational reserve. The Organization is supplementing operational revenues with grant funds and began participation in the School Based Health Services Medicaid program in FY 17.

The Organization's debt ratio is higher than the target measure, but not significantly higher than the floor measure of 0.9. The Organization's total liabilities are influenced by large amounts related to start up operations and the funding of facility improvements.

Sustainability - The School has generated a deficit through June 30, 2016. Expenses include significant amounts of non-cash depreciation expense and non-cash management fee expense, which allows the School to report a positive net cash flow. As the School matures, this ratio will be improved.

\$1.1M in rent expense for lease beginning in 2015 and expiring in 2030 with three 5-year renewal periods. During the first 3 years of the lease, payment terms are set relative to the DC facilities allowance.

The total deferred rent liability at June 30, 2016 was \$3.8 million.

The amount due to The Children's Guild, Inc. as of June 30, 2016 relating to the line of credit was \$1.4 million.

DC PCSB Comments

The Children's Guild, Inc. (the Guild) has several major programs, including management of charter schools in Washington, DC, and Maryland, and management of non-public special education schools in Maryland. The Guild assisted in the School's initial formation and provides management and administrative services to the School. The annual fee is 12% of gross revenue, plus reimbursement of certain costs paid by the Guild on the School's behalf. In 2016 the Guild waived the annual management fee of \$985,638.
