# Early Childhood Performance Management Framework (EC PMF) Meeting Goals:

- a. Discuss business rules for floors and targets for student level assessments
- b. Discuss and vote on floors and targets for Teacher Interaction, Attendance, and Re-Enrollment



### **PK Business Rules**

- Possible <u>Progress</u> Business Rules:
  - 1. Progress determined for <u>every</u> child
  - 2. Progress determined for children who <u>end</u> school year below developmentally appropriate level
  - 3. Progress determined for children who <u>start</u> school year below developmentally appropriate level
  - 4. Progress determined for students who start or end school <u>above</u> developmentally appropriate level
- Do we remove students above developmentally appropriate level from denominator and focus on progress for students who need it to be ready for kindergarten?

Teachstone:

- 6-7 = high score
- for all domains
- 3-5 = medium
- 1-2 = low

### **Business Rules:**

#### Target:

• Use CLASS defined high score (6-7) as target if sector domain 90<sup>th</sup> percentile is above 6

• If sector domain score is below CLASS defined high score (6-7) use 90<sup>th</sup> percentile **Floor**:

• Use 10<sup>th</sup> percentile of sector scores for floor on each domain

Weighted Average: Use two year next year and three year weighted average 2015 and beyond

## **Proposed Business Rules: Floors & Targets** (non-student level assessments)

### **Re-Enrollment and In-Seat Attendance:**

- 90<sup>th</sup> percentile for target, 10<sup>th</sup> percentile for floor
- 3 year weighted average (same as ES/MS PMF) after 3 years
- Until then, 1 year same as ES/MS floors and targets,
  2 year weighted average year two
- CLASS:
  - Target:
    - Use CLASS defined high score (6-7) as target if sector domain 90<sup>th</sup> percentile is above 6
    - If sector domain score is below CLASS defined high score (6-7) use 90<sup>th</sup> percentile
  - Floor:
    - Use 10<sup>th</sup> percentile of sector scores for floor on each domain
