The Stokes School food service department prepares and serves breakfast, lunch and supper to students and staff on a daily basis. All of the food is prepared fresh daily, from scratch, with local ingredients as much as possible. We partner with local organizations such as DC Farm to School, the Washington Youth Garden and local meat providers.

Students engage in creative activities to supplement as well as complement student learning. Students enrolled in the after school program not only learn the language arts and mathematics fundamentals but are also be exposed to world cultures. In addition to these learning activities, students engage in visual arts, arts & crafts, music and movement, dance, steel drums, African drumming, violin, guitar, reading and literacy groups and other activities.
