Members of the DC Public Charter School Board (2 attachments),

I urge you to oppose the proposed campus closure and consolidation amendment of the Cesar Chavez PCS (CC PCS) that is before you for consideration. At this point, the PCSB needs to ensure greater transparency and frequent reports of all data.

1. The proposed grade 9 through 12 "enrollment matrix" projects a future student retention policy that is unrealistic and contradicted by CC PCS enrollment history since 2005. It projects the following grade 9 through 12 enrollments from SY2019-20 through 2024-25 (each color follows a cohort of students from grade 9 to grade 12):

Next year's 9th grade is projected to remain unchanged in size; the next two are projected to increase from 110 to 115.

Table 1 in the attachment lists the enrollment numbers of the combined grade 9 cohorts of Capitol Hill HS and Parkside HS starting in 2007-08 and follows them as they advance to grades 10, 11 & 12. The totals of the most recent 8 cohorts with complete data through grade 12 are shown here. Cohorts starting in 2010-11 include Bruce Prep's 9th grade.

- 2. CC PCS should not be managing private placements of special education students (Table 2, attachment; from the 2017-18 enrollment report). That is a function for DCPS and doesn't require an additional "middleman." The PCSB should determine what this administrative function costs CC PCS in staff and funding.
- 3. Please require full transparency for all enrollment data: where withdrawn & transferred students enroll; why they leave; numbers of replacement students; annual teacher turnover and reasons for leaving; testing data prominently posted.

In Table 1, each color represents a cohort of students as it rises from gr9 to gr12 (Col C - F). Col H - K show the nr of graduates, adjusted cohort and graduation rate. Col L shows the nr dropped fr the cohort since gr 9. Col M shows the completion rate, the nr of graduates as a % of starting 9th graders.

The adjusted cohort is the base number or denominator. It starts with the 9th grade audited enrollment (counted each October); students admitted after the count are added to it; students withdrawn are subtracted from it. A student is not withdrawn until the sending school receives confirmation that the student was enrolled in another school.

Completion rate is an indicator that measures the % of starting 9th graders that graduated within four years. It's useful as a comparison to the ACGR. If there is a wide gap between the ACGR and the completion rate, it indicates a problem in retaining students that should be analyzed by responsible officials.
