<u>Called to Order:</u> Mr. Bhatia called the meeting to order at 8:48 A.M.

<u>Approval of September Meeting Minutes:</u> Ms. Drumheller moved to approve the September meeting minutes. Ms. Little seconded the motion.

**Executive Report:** Dr. Miller shared updates on academics, operations, assessments, compliance and culture.

**School Improvement Plan:** Ms. Barford shared a portion of the Chavez school improvement plan, including annual goals for each PMF metric and monthly benchmarks.

Ms. Drumheller motioned to approve a second term for Ms. Salcido. Mr. Bhatia seconded the motion. All board members voted in support of extending Ms. Salcido's board membership for a second term.

Ms. Salcido shared resumes for two parent board members: Donna Stewart and Amber Jackson. Ms. Little motioned to invite Ms. Stewart and Ms. Jackson to join the board. Ms. Drumheller seconded the motion. All members present voted to invite Ms. Stewart and Ms. Jackson to join the board.

Ms. Salcido and Ms. Little shared resumes for several additional potential new board members. All members agreed to extend invitations to Dr. Lisa Grillo and Ms. Lynn McNair. The board will vote on membership if and when candidates accept their respective offers to join the board.

## Executive Session was held at 10:26am and ended at 10:48am.

**Budget Approval:** The board reviewed a revised budget, updated to reflect current student enrollment numbers. Ms. Drumheller motioned to approve the budget. Ms. Little seconded the motion. All members voted in favor of approving the revised budget.
