



Notice of Petition to Amend Charter:  
Governance Structure– **Harmony DC PCS**  
ACTION: Open for Public Comment

PUBLIC COMMENT ACCEPTED UNTIL: September 21, 2020

**SUMMARY:** The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a written request submitted by Harmony DC Public Charter School (Harmony PCS) on August 17, 2020 to amend its charter agreement by recognizing the school's contract with a management organization. This kind of request constitutes a change to the school's governance structure.

Currently in its seventh year of operation, Harmony PCS educates students in grades kindergarten through five. During its five-year charter review in school year (SY) 2018 – 19, DC PCSB approved the school to expand to include grades pre-kindergarten 3 (PK3) and pre-kindergarten 4 (PK4), provided that the school contract with an experienced early childhood operator to manage the new classes. Harmony PCS has since contracted the AppleTree Institute to operate its PK3 and PK4 program.<sup>1</sup> Over the next year, Harmony PCS will work with the AppleTree Institute to develop its opening plans. In SY 2021 – 22, the school will begin offering PK3 and PK4 classes.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its governance structure.

- Comments must be submitted on or before September 21, 2020.<sup>2</sup>
