

Notice of Request to Amend Charter: Graduation Requirements – **Digital Pioneers PCS** Open for Public Comment

Public Comment Accepted Until: July 19, 2021

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to comment on a request from Digital Pioneers Academy Public Charter School (Digital Pioneers PCS) to amend its charter to include graduation requirements. The school submitted its request on June 25, 2021.

Currently in its third year of operation, Digital Pioneers PCS educates 337 students in grades 6 – 8 in Ward 6. The school's mission is to "develop the next generation of innovators. We prepare students to meet or exceed the highest academic standards, while cultivating the strength of character necessary to both graduate from four-year colleges and thrive in 21st-century careers." In December 2020, DC PCSB conditionally approved Digital Pioneers PCS's request to expand to grades 9 – 12 and increase its enrollment ceiling from 360 to 840.

Now that it has DC PCSB's approval to open a high school, Digital Pioneers PCS proposes adding graduation requirements to its charter agreement. Under the proposed graduation requirements, students must earn a total of 26.5 credits to graduate. Two of those credits must be in computer science, and two credits must be in leadership development.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its graduation requirements.
