**SUBJECT: Data Collection Summary for the Revised Accountability Framework**

**DATE: May 16, 2022**

DC PCSB is creating the policy and conditions to support a network of public charter schools in Washington, DC, offering families quality, equity, and diverse educational choices. This request aligns with our Strategic Roadmap<sup>1</sup> Priority of Excellent Schools.

**Proposal**

The DC Public Charter School Board (DC PCSB) staff recommends its Board open for public comment the *Data Collection Summary for the Revised Accountability Framework* (Attachment A) in preparation for amending DC PCSB’s Performance Management Framework<sup>2</sup> (PMF). Public comment will remain open until June 27, 2022, with a public hearing also on that date. The Board is scheduled to vote on the proposal at its meeting on July 18, 2022.

## Summary

DC PCSB staff proposes introducing the *Data Collection Summary for the Revised Accountability Framework* as an inventory of the data that will be collected to model potential approaches to the revised framework; not every data point will be used in the revised accountability framework. Data analyses and business rule modeling will inform discussions with stakeholders to make decisions on floors, targets, and weights for the revised framework. The final list of measures, including which will be disaggregated by student group, will be identified during school year (SY) 2022-23, the data modeling year (pilot year). A new technical guide, anticipated to be released in Spring 2023, will detail the revised accountability framework.

## Changes from the PMF to the Revised Framework for Grades Pre-Kindergarten (PK) through Twelve and Adult Education

There are several potential changes from the categories and measures that existed in the PMF to those that will compose the revised accountability framework. One of the most notable changes is a specific focus on comparing student group performance across measures, holding schools accountable for demonstrating successful academic outcomes for all students, regardless of race/ethnicity, disability status, English learner status, or socioeconomic status. Additional significant changes and updates are in the chart below.

### **Stakeholder Engagement**

DC PCSB’s goal is to develop a revised accountability framework in partnership with school leaders and other stakeholders. To this end, we have engaged and will continue to engage stakeholders throughout this process. This school year there were two Advisory Groups, PK-12 and Adult Education, that met regularly to discuss revised accountability framework topics specific to their school types. Next school year’s Taskforce meetings will likely be organized by framework, as they have been in previous years, and will meet to discuss further details about the revised framework, including targets, weights, and business rules.

Sept 2022 – April 2023	Taskforce will meet monthly, by grade band, to help determine weights and scoring (e.g., floors, targets)

**Policy Background**

The School Reform Act (SRA) grants DC PCSB authority to hold DC public charter schools accountable for fulfilling their duties and obligations under the SRA. DC PCSB created the PMF to hold schools serving similar grades to the same set of standards. DC PCSB has foregone a PMF score for the last two school years due to a lack of data availability during the COVID-19 pandemic. DC PCSB’s COVID-19 Impact Policy<sup>4</sup> outlines how LEAs will be held accountable during the years for which the PMF is not published.

In June 2021, DC PCSB released its Strategic Roadmap,<sup>5</sup> which will guide its oversight work in the coming years. One of the goals under the strategic priority of Excellent Schools is to “pilot and implement a new accountability framework.” This revised accountability framework’s principles are to:

1. Hold schools accountable for ensuring that all students meet or exceed high performance and/or improvement targets, acknowledging that an excellent school is equitable;
2. Reward high levels of growth for all students;
3. Provide a rigorous, attainable benchmark to measure school performance; and
4. Focus primarily on outcomes, both performance and school climate measures.
