

Notice of Petition to Amend Charter: Enrollment Ceiling Increase – **YouthBuild PCS** Open for Public Comment Public Comment Accepted Until July 17, 2023

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a request from YouthBuild DC Public Charter School (YouthBuild PCS) to amend its charter agreement by increasing its enrollment ceiling beginning in school year (SY) 2024 – 25. The school submitted its request on June 1, 2023.¹

Founded in SY 2005 – 06, YouthBuild PCS educates 125 adult learners at a facility located at 3220 16th Street NW in Ward 1. The school's mission is "to engage and empower older youth and young adults by providing a college preparatory education, career training in high-growth occupations and/or college-credit classes."

The school seeks to increase its enrollment ceiling by 28 students over time until it reaches a capacity of 150 students in SY 2028 – 29.

PUBLIC MEETINGS: The public hearing will be on July 17, 2023 at 6:00 p.m. The vote will be on August 21, 2023 at 6:00 p.m. Please visit www.dcpcsb.org to register.

- 3. Submit voicemail testimony by calling (202) 328-2660 and selecting option 2. You will have up to five minutes to record your testimony. All comments will be transcribed and made available to the public upon receipt.

¹ Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes the maximum enrollment schedule.
