

**SUMMARY**: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to comment on a request from KIPP DC Public Charter School (KIPP DC PCS) to amend its charter by modifying its goals and academic achievement expectations. The school submitted its request on April 14, 2023.<sup>1</sup>

Currently in its twenty-second year of operation, KIPP DC PCS educates 7,358 students in grades pre-kindergarten 3 (PK3) through 12 across 20 campuses in Wards 5, 6, 7, and 8. The school's mission is to provide "highly skilled teachers and leaders, more time in school, a rigorous college preparatory- curriculum, and a strong culture of high expectations and support [to] help our students make significant academic gains and continue to excel in high school and college."

KIPP DC PCS seeks to modify its mission specific survey goals. The school proposes changing the response rate requirement for its KIPP DC Family Survey from 50% network-wide to 30% at each campus. Additionally, the school proposes utilizing a new teacher survey tool. KIPP DC PCS seeks to use The New Teacher Project (TNTP) Insight Survey, with a focus on Diversity, Equity, and Inclusion (DEI) domain performance. The proposed goals, if approved, will take effect beginning in school year (SY) 2023 – 24.
