

Notice of Request to Amend Charter Goals and Academic Achievement Expectations– **Maya Angelou PCS**

Open for Public Comment

Public Comment Accepted Until July 17, 2023

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to comment on a request from Maya Angelou Public Charter School (Maya Angelou PCS) to amend its charter by modifying its goals and academic achievement expectations. The school submitted its request on April 28, 2023.¹

Currently in its twenty-fifth year of operation, Maya Angelou PCS educates 539 high school, alternative and adult education students across three campuses located in Ward 7. The school's mission is to:

Create learning communities in lower-income urban areas where all students, particularly those who have not succeeded in traditional school settings, can grow academically and socially. At Maya Angelou, our students develop the academic, social, and employment skills that they need to build rewarding lives and promote positive change in their communities.

Maya Angelou PCS – High School currently has nine goals that measure student and school performance in the following areas: reading progress, math progress, writing progress, graduation rate, discipline, attendance, re-engagement, social-emotional learning, and college and career readiness. The school proposes removing Maya Angelou PCS – High School's writing progress goal. If approved, this change will take effect beginning in school year (SY) 2023 – 24.
