



Notice of Petition to Amend Charter:  
Enrollment Ceiling Increase – **Inspired Teaching PCS**  
Open for Public Comment  
**Public Comment Accepted Until August 19, 2024**

**SUMMARY:** The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a request from Inspired Teaching Demonstration Public Charter School (Inspired Teaching PCS) to amend its charter agreement by increasing its enrollment ceiling. The school submitted its request on May 31, 2024.<sup>1</sup>

Currently in its 13<sup>th</sup> year of operation, Inspired Teaching PCS educates 522 pre-kindergarten 3 (PK3) – 8 grade students at one campus located in Ward 5.

Inspired Teaching PCS is requesting a ceiling increase of 16 students for a total maximum enrollment of 536 students. If approved, the proposed change will be implemented in school year (SY) 2025 – 26 and beyond.
