

Notice of Charter Reviews – **Multiple Schools**: Capital Village PCS I Dream PCS

Washington Global PCS
Open for Public Comment

Public Comment Accepted Until April 7, 2025

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comments on the DC public charter schools listed below which are up for a charter review on April 7, 2025. Pending DC PCSB staff's analysis, the Board may elect to do one of the following for schools up for review: 1) continue the school's charter without conditions, 2) conditionally continue the school's charter by imposing annual or interim targets or requirements it must meet, or 3) initiate charter revocation proceedings.

- Capital Village Public Charter School (Capital Village PCS)
 Capital Village PCS is up for its five-year charter review. The school operates one campus in Ward 5, where it serves students in grades 5 8. Its mission is "to prepare all students, regardless of background or circumstance, to reach their full potential in college, career, and life in order to become agents of change in their communities."
- 2. I Dream Public Charter School (I Dream PCS)
 I Dream PCS is up for its five-year charter review. The school operates one campus in Ward 7. It serves students in grades pre-kindergarten 3 (PK3) 5. Its mission is: "I Dream PCS is an intentionally transformative learning community that nurtures children in grades PK3 5 to imagine and fulfill their dreams and aspirations. We collaborate with communities to customize purposeful, self-directed learning opportunities for all children. I dream. I learn. I become."
- 3. Washington Global Public Charter School (Washington Global PCS)
 Washington Global PCS is up for its 10-year charter review. The school operates one campus in Ward 6, where it serves students in grades 6 8. The school's mission is: "Washington Global Public Charter School (Washington Global) is a community school open to all middle school students in Washington, DC. It utilizes a rigorous, internationally-based academic and cultural curriculum, which integrates project-based learning, service-learning, technology, and language acquisition to develop enterprising and competitive global citizens."

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., DC PCSB is required to review each DC public charter school's performance at least once every five years.

PUBLIC MEETING: DC PCSB will discuss and vote on Capital Village PCS, I Dream PCS, and Washington Global PCS on April 7, 2025, at 6:00 pm. Please check www.dcpcsb.org to register to attend the meeting.
