A. Review Progress Metrics

Big month with Match Day. Thanks to the board and leadership team Leadership team has remained driven Matched with 84 students 24 on the wait list have been moved off 9 more 9th graders and 2 more 10th graders
119 students with 8 declines- going to closer schools
That will put us in good position to hit the base goal of 153
Had a target of 220 and hit it
45 families have started filling out paperwork already

IV. Academic Committee

A. General Status of Student Body and School Operations

Mary: Sharing data and content updates from committee meeting Attendance: They meet to discuss the chronically absent

This week: In seat attendance is 92.4%- meeting goal of 92%

Recovery work is being done to get girls back on track Discussed why data looks the way it does Number of students with recovery Pass rate indicates promotion to 10th grade Actively supporting students not on track for promotion Created a pathway to get on track- Support Saturday- peer tutoring, teacher presnet, for any assignment they need to recover to get a score. Looking for a 3 or highter. Also offer Wednesday office hours Academic success mentors- get support for a goal. Time, patience, and individualization helps. May 1 closes trimester. June will determine if any will need to go to school in the summer. Target no more than 7% to need summer enrichment

Two big focus areas Intentional relationship building with students Interventions-same this semester- small group and one on one support Dynamics Teachers meeting twice a month. Gen ed and special ed working together Draft data dashboard- with the most important and helpful info

Started Sisterhood Socials on Wednesday. Not open to the public- just for staff and students- and especially for students to connect with each other.

V. Governance Committee

B. Addressing Initial Staggered Term Limits - Renewing a Member Status

Staggered term limits

The Board discussed the staggered terms of the initial board members and decided to take the discussion offline. The Governance Committee will report back next month.

C. Term Limits of Other Members

Parent term: in by laws, parent trustee members are the same as others, including the 3 year term. This creates a challenge for parents who are juniors and seniors. Parent membership ends when girls graduate. So proposed 2 year terms. And parents can serve two 2-year terms.

Language specifies parents, but propose adding legal guardian. Add ex-officio member from parent group- also sit on board- participate but not vote.

Proposing a parent representative - PTA- to the board- non-voting Proposing a student representative to the board- non-voting

Extending term of office to a 2nd term. But anyone can leave at any time.

All will be voted on next month.

VI. Finance

A. Initial Review of Detailed Level SY22 Budget

Budget: March- budget predicated on 153 students Board members will receive the detailed budget Will vote in May 26 employees Changes from buckets in March: 26 employees OSSE has published per pupil allocation- 3.6% increase bumped up the revenue. Still looking at a positive year. Rent goes up if more than 153 students. But 153 enables GGA to meet its rent obligation.

Review spreadsheet. Send questions to Maura by May 7.

Can set up office hours week of May 10th if people have questions. Will give a chance to make changes before voting at the May meeting.

- C. Closed Session for Policy Regarding Personnel Compensation Compensation was discussed

There is a line item bonus for returning staff.

An ongoing framework for ED compensation was discussed and partially resolved.

The board favors having a committee assess at minimum, every 3 to 5 years, whether our compensation is in line with other DC charter schools.

Also discussed- what the board will do to celebrate Teacher Appreciation Day for GGA teachers and staff. Shalini has the lead.
