### 3. ED Update (J. Gomez)

- Enrollment Update
  - Enrollment closed at the end of March; On match day (April 2nd), we had 21 families matched; they have already started enrolling
  - We will continue to recruit and continue to enroll; We are at 75 and our goal is
    105
- In-Person, Hybrid and Virtual Learning--
  - Developing the Plan for following Spring Break, Summer and next Fall
  - About 75% of staff and families are open to in-person learning
  - There will be a hybrid approach where some provide in-person learning and some virtual. Almost everyone will be able to stay with their cohort of learners and staff

#### Summer School

- We will have learning opportunities that will provide many of the same normal school year for our learners but it will be joyous and take advantage of outside.
- We are a DC summer youth employment program site and will have some teens working in operations
- We are working with City Bridge on a design sprint program that is creating tutoring programs

#### Hiring

- We are starting hiring. We are hiring for a PreK 3-PreK 4, adn Elementary 3rd-4th grade. Feel good about retention and ability to fill vacancy
