### C. Approve Minutes: November

### A. Academic Results Fall 2020

The Academic Committee presented to the Board the Academic Results of Fall 2020. The report included three main aras of focus: 1) Improvement of Attendance, 2) Academic strategies and overall MAP test results and 3) Steps the school is taking to promote Equity and support student belonging and wellness.

The Committee is analyzing all data by grade and demographics to best understand how different groups are performing under current remote leaning conditions as well as to best inform the design of a hybrid learning model as the on-campus learning opportunity expands.

The Executive Director provided a report including updates on Instructional Leadership Transitions (recently appointed Acting J.F. Cook Campus Principal, Acting J.F. Cook Campus Assistant Principal, Acting Instructional Guide, Director of Innovation) as well as on the upcoming 10 Year Review of Charter report expected to come out by the end of this month.

Report also included brief updates on current feasibility studies to expand building capacity at Calle Ocho Campus and the ongoing efforts of the School's Leadership considering expansion of on-campus learning, contingent to the District's Health Metrics.
