- April Board Meeting Agenda
 - > Susan Sabella moved to approve the agenda. Alteria Brown second that motion.
- Motion to adopt the minutes
 - Austin Alderdice approve the minutes. Kerry Smith second the motion.
- Open Meetings Act:
 - > Requires a motion to close the open meeting and to go into a closed meeting for business matters
 - Motion was granted (Susan Sabella moved to go into a closed session. Austin Alderdice second the motion.)

DISCUSSION

Discussion: (Items/Knowledge Shared)

- Finance Committee Updates:
 - Budget:
 - > Full presentation to the Public Charter School Board at the June meeting for the 2021-2022 School Year budget
 - ➤ Current assumption around enrollment of 375 students: net income will be -1.5m. 1.3m of that is one time expenses related to the final payments of Lamond building. The net income net income will be -\$200,000.
 - ➤ Ending cash balance as of June 30, 2022 will be 2.5m which equivalent to 75 days of cash on hand.
 - Enrollment
 - Lamond Enrollment Update
 - o 4.9% withdrawal rate year to date
 - o Highest in Pre-kindergarten 3 through Kindergarten

- Three students in each pre-kindergarten 3, pre-kindergarten 4 and kindergarten have withdrawn post-audit, one of which was excluded from the Uniform Per Student Funding Formula roster
- o One student enrolled post-audit who transferred from Tolson
- Tolson Enrollment Update
 - 10 Uniform Per Student Funding Formula students have withdrawn post-audit, including two students that withdrew in the last month. One of those transferred to Lamond.
 - o 2.74% withdrawal rate to date

> Re-Enrollment Update

- Friendship Public Charter School Acquisition was approved
- Parents received communication from both Imagine and Friendship Public Charter Schools notifying them as part of the acquisition Pre-k3 to 4th grade families have the right to re-enroll at Friendship. The 5th grade students will need to go back to MySchoolDC and specify Friendship Public Charter School with a transfer preference.
- My School DC drafted a memo dated 5.27.21. The purpose of this memo s to documented all changes and communication My School DC has made to date in response to the intended closure of Hope Community Public Charter School- Lamond Campus at the end of 2020-2021 school year, and the acquisition of its assets by Friendship Public Charter School-Ideal campus.
- o Sandra Majano will collaborate with Friendship on re-enrollment
- On May 27, 2021, Ken, Stephanie and Candice met briefly to discuss communication, messaging, and marketing, plans for Town Halls or information sessions to answer questions and/or assist with enrollment related matters.
- ➤ Lamond School Year 2021-2022 Re-enrollment Update
 - 0 student matched
 - 0 students waitlisted (Lamond's waitlist has been removed from Hope's MySchool account)
 - o 13 students who have accepted offers from other schools
 - o 12 students (from Prek-3 to 4th) submitted intent to return
- > Tolson School Year 2021-2022 Re-enrollment Update
 - o 33 students matched
 - o 35 students waitlisted
 - 12 students leaving

Operations Update

- Enrollment- Lamond and Tolson will be managed by the respective new partners-Friendship and Phalen Leadership Academies
- Contracts/Vendors- Phalen Leadership Academies and Friendship are identifying those vendors or services they are interested in maintaining/we will move to terminate or end others accordingly
- Marketing-Effective immediately, Imagine Schools has been advised to release access to all Hope's marketing channels to Hope Board and its designee, Phalen Leadership Academies (PLA) for Tolson and Friendship Schools for Lamond. Further communication that may be needed to be channeled to the community about the endof-the year closeout can be done through the Board's designee in collaboration with Stephanie Minor and her designees.

o First half of property taxes paid in March (\$94,564.74 Lamond and \$142,576.31 Tolson)

 Charter School Real Property Tax Rebate Application submitted tomorrow no later than June 1st

Facility Updates:

- ➤ Facilities Managers monitor inventory of supplies and equipment to ensure consistent cleaning and disinfecting
 - Monitor safe, correct use and storage of cleaners and disinfectants, including soring products securely away from students
- > All lavatories are inspected throughout the day and sanitized when necessary
 - Immediately after the facilities are vacated each day, lavatories are sprayed down, using the IonoMax electro static sprayers, utilizing HOCL disinfectant
- > Buildings are sanitized daily at the end of each school day utilizing lonoMax electro static sprayers
- Monitor and empty trash cans during breakfast/lunch service in classroom at both campuses
- > Disinfect and wipe-down high-traffic areas and touch points throughout the day
- Wednesday Schedule
 - Detailed cleaning: deep cleaning and disinfecting
 - Wet mop all floors and burnish if possible
 - Schedule any vendors who might have to do some work
- Facilities Reopening Budget
 - Projected Facilities Reopening Budget: \$284,777
 - > Actual Facilities Reopening Costs (5.21.21): \$147,191
