Approval of Minutes: May 3, 2021 Board Meeting minutes were approved, with the amendment that Aleta Margolis was not present.

School Update

Head of School reviewed high school outplacement data for graduating 8th graders, current school year produced ITDS' highest level of placement in specialized high schools. Discussion of return to school plans to maintain safe operations, including for unvaccinated children. Return to school survey underway, and forms from OSSE to apply for individual accommodations for remote learning are now available.

There is sufficient staff to staff summer school, and leadership is considering options for after-school tutoring and Saturday school for the coming school year

HVAC system assessment was complete. Air purifiers will be in all classrooms, and updated filters are in place. Assessment firm has done dozens of school reviews, good marks were received on our current HVAC system. The large common areas need upgrades, which will be done over the summer. Summary assessment will be posted with meeting minutes.

The Public Charter School Board has approved an at-risk preference option for charter schools. Schools have until July 25th to apply to be able to adopt the option, effective for either SY22-23 or SY23-24. The Board discussed the application process, ITDS' readiness based on track record, alignment with mission, and questions regarding the process and commitments.

Motion to approve creation of an At-Risk Preference Committee of the Board to study the option and make a recommendation to the full Board.
