SPECIAL FOCUS HAS BEEN GIVEN TO RESIDENTS OF WARDS 7 AND 8 WHERE THERE IS THE GREATEST CONCENTRATION OF ADULTS WITH CHALLENGES IN EDUCATION AND WORKFORCE PREPAREDNESS AND THE FEWEST PROGRAMS.
