




number of adult students enrolled in public charter schools

Background

Created in 1996, the DC Public Charter School Board (DC PCSB) is an independent government agency of the District of Columbia that provides academic and financial oversight to 133 citywide public charter schools that are managed by 68 independently run nonprofit organizations called Local Education Agencies (LEAs).

As the sole public charter school authorizer in Washington, DC, our role is different from that of a school district. We do not operate or direct the management of public charter schools. That is the job of each school's board of trustees. Instead, we create the policies and conditions that empower teachers and school leaders to do their best work – and that's educating students.

Dear Education Community:

We are now in our third year of the COVID-19 pandemic. It's a simple statement to make, but it alone does not begin to tell the real story.

Yes, over a million Americans died from the disease (about 1,300 in Washington, DC, alone), but we as parents, caretakers, school leaders, teachers, and others responded to it in dramatically different ways. Some embraced vaccination and masks; others did not. Some families lost loved ones while others did not. And some of us stayed employed throughout the pandemic; others lost their jobs and struggled to make ends meet.



And while many students successfully moved to virtual learning, others did not. And this makes the story of education during a pandemic much more complex.

In DC, the overall number of public school students dropped slightly overall during the pandemic, while the number of those who attended public charter schools went up by about three percent (source: DC's Office of the State Superintendent of Education).

Even though these are small numbers, they suggest important points.

First, public charter schools are their own school districts, which allows them to be uniquely responsive to their students, families, and teachers. For example, some families wanted their students to wear a mask and, for that reason, many schools kept the mask mandate even after it had been lifted. Or, in the first year of the pandemic, some public charter schools kept classrooms open because that is what their families requested.

Second, the pandemic taught us that schools are more than just places to learn. They are the centers of our community—where hungry students get a meal, receive health care, have access to the Internet, and feel nurtured and appreciated—and so much more.

While the pandemic is not over, our schools are taking these lessons and making changes to better serve their students. For example, some have expanded their kitchens and included public health support to ensure their students have healthy meals and better health care. I'm extremely proud to know our LEAs have also ensured that our students receive the tools and other interventions they need, like tutoring, to remain academically equipped for their futures. And others are bringing in outside assistance to help with teacher satisfaction and retention.

This Annual Report, highlights the efforts of the DC Public Charter School Board over the past 12 months to support schools and students.



Academic Oversight

We collaborate with school leaders, families, elected leaders, education agencies, and partners to determine how best to strengthen and improve our academic oversight of public charter schools without impeding a school's freedom to make decisions that are best for their school communities. Our oversight work aims to improve the experiences of all DC students, especially those from historically marginalized groups. Our approach to academic oversight consists of:

Charter Reviews and Renewals

The School Reform Act requires DC PCSB to conduct a charter review of each school at least every five years. We evaluate each school to determine whether it is meeting the charter goals and academic achievement expectations, legal compliance, and fiscal management requirements set forth in the charter agreement.

SY 2021 - 22: 5-Year Charter Reviews

We did not conduct five-year reviews during the school year 2021 – 22.

SY 2021 - 22: 10-Year Charter Reviews

In school year 2021 – 22, staff conducted and the Board approved four, 10-year charter reviews. *See Board Actions Pg. 28 for date of vote.*

SY 2021 - 22 Charter Renewals, 15-Year and Beyond

Interventions and Correction of Deficiencies

DC PCSB issued these conditions to the following two public charter Local Education Agencies (LEAs) during their 10-year review:

BASIS DC PCS

BASIS DC PCS will submit a plan that will show how they will support serving more students with disabilities. This plan will describe the academic programming and personnel needed and include strategies that ensure the school's capacity to offer special education services across all settings and needs.

DC Scholars PCS

DC Scholars PCS will draft an academic improvement plan that will include specific strategies they will use to improve academic outcomes and measure academic progress for all students they serve.

Qualitative Site Reviews

The purpose of the Qualitative Site Review (QSR) is to provide DC PCSB, public charter school leaders, and other community members with qualitative evidence to complement the quantitative evidence that is gathered in the accountability framework.

The QSR is intended to provide a snapshot of overall quality, not to evaluate individual teachers. DC PCSB conducts unannounced school visits and selects a random sample of classrooms. DC PCSB does not typically observe electives but will observe an elective class if it is critical to the school's mission. While DC PCSB may note general trends across grade levels or subject areas, the QSR team will not give recommendations or share individual observation results. The QSR team produces a final report containing a qualitative assessment for each campus within the LEA.

QSRs comprise the following components:

- A sector-wide training with school leaders for all campuses that will be observed during the following school year to gather information about the school's mission, vision, academic program, and charter goals;
- 2. A review of student English language arts (ELA) and math work samples;
- 3. Unannounced observations of 50 percent of core-content classrooms; and
- 4. A scheduled debrief with the school leadership team and DC PCSB staff.

Non-Academic Oversight

Compliance Review

As part of our oversight practices, we conduct an annual Compliance Review to ensure public charter LEAs comply with applicable laws and charter requirements.

The Compliance Review consists of DC PCSB collecting several required documents and information electronically from each public charter LEA to review. (A complete list of compliance documents due during the 2021 – 22 school year is available in the Annual LEA Document Submission Calendar.) If any documents are deemed inaccurate or incomplete, the item is returned to the public charter LEA for revisions. After the review, DC PCSB staff generates a Compliance Review Report for each public charter LEA that rates each compliance requirement as either compliant, in progress, or not compliant. A "compliant" rating means the school has satisfied the compliance standards. A rating of "in progress" means the school has not satisfied the compliance standards but has provided an explanation or evidence that the issue is being remedied in a way that DC PCSB accepts as reasonable. A rating of "not compliant" means the school has not satisfied the compliance standards and has not provided an explanation or evidence of how the issue will be remedied, the timeline for addressing the issue has not been adequate, or the school has been non-responsive in addressing the issue. No schools have received a "not compliant" rating this school year.

As of the date of publication, there are currently 30 schools that are in progress toward being compliant. This is the result of COVID-19-related delays in processing the following items:

- Board rosters;
- Certifications for staff to administer medicine; and
- Certificates of occupancy.

DC PCSB granted schools extensions as needed, working with school staff to help them understand the requirements and allow reasonable time to acquire the appropriate documents. However, given the extenuating circumstances of this year and the ongoing pandemic-related limitations that have driven these compliance issues, DC PCSB will continue to work with schools to ensure they are entirely in compliance. DC PCSB recognizes that, in most cases, these issues are beyond the school's control. Schools will be required to address these compliance issues fully by September 2022.

Late or improper submission of compliance documentation may cause the school to receive an Early Warning Notice, an Out of Compliance Notice, and a Notice of Concern if the issue is not cured.

In February, DC PCSB staff generated a Compliance Review Report to share with school leaders, including Board members. Then the results of the Compliance Review were shared with the Board and the public and read into the record at the April 2022 Board meeting.

Financial Oversight

Each year, DC PCSB conducts an assessment of the finances and operations of every public charter LEA. These reviews assess if they have sufficient finances for the year plus any contingencies. If a school has engaged in a pattern of non-adherence to generally accepted accounting principles, has engaged in a pattern of fiscal mismanagement, or is no longer economically viable, we are required to close it per DC law.

Financial Monitoring

We monitor the financial health and management of public charter LEAs using three primary tools: (1) the annual Financial Analysis Report, which provides a comprehensive assessment of the school's financial health, based primarily on audited financial statements; (2) a review of the annual budget of the school's operations; and (3) a review of interim LEA financial statements, either quarterly or monthly, including a Statement of Financial Position, Statement of Activities, and Statement of Cash Flows.

Additionally, public charter LEAs undergo an in-depth review of their financial health and management as part of the review or renewal process every five years.

Financial Compliance

As part of our compliance review, audited financial statements also include a supplemental schedule that lists all contracts worth more than \$25,000 per year that the public charter LEA entered into during the fiscal year. Financial Transparency





Interventions and Correction of Deficiencies

If we have concerns about a school's financial health, we collaborate with the school to address them as early as possible. In most cases, we start with two actions: (1) additional monitoring, including more frequent interim financial statement reviews and budget revisions, and (2) informal discussions about the LEA's financial challenges and improvement plans. We subsequently disclose in the Financial Analysis Report (available on DC PCSB's website at https://dcpcsb.org/financial-analysis-reports) the steps taken or that will be taken by the LEA to rectify each deficiency identified in the audit, to be carried out in a manner consistent with our recommendations.

In cases of more imminent concerns, we may take more formal intervention actions, such as citing a public charter LEA for fiscal mismanagement or instituting a Financial Corrective Action Plan, which sets specific performance targets for the LEA's finances. These actions would take place during a monthly public Board meeting. No public charter LEAs required intervention to address financial and operational concerns in FY 2021 (see School Reform Act Requirements on page 31). However, one public charter LEA was subject to financial conditions at its charter renewal prior to fiscal year 2021 and the conditions were satisfied this fiscal year. Additionally, we continue to monitor the compliance of one public charter LEA on a financial corrective action plan that was effective prior to FY 2021.









ENDURING PARTNERSHIPS.

Strengthen dialogue between families, school communities, and residents to create a shared understanding of our work, solicit feedback, and develop new partnerships across DC.

Working with Families

Input from parents is at the heart of the work DC PCSB does to ensure every DC student receives a quality education that makes them feel valued and prepares them for lifelong learning, fulfilling careers, and economic security. Between October 2021 and June 2022, our Parent Alumni Leadership Council (PALC) met nine times virtually to continue ongoing discussions surrounding our Strategic Roadmap and priorities, revised accountability framework, PALC policy, charter goals, school immunization requirements, and communications to families. For the first time, PALC established three committees: Special Populations, City Services/Health & Safety, and Communications. These committees will seek to advise and offer feedback to the Board on policy matters and more.

Working with School Leaders

DC PCSB held two Charter Leaders meetings (October 2021 and April 2022) to provide an update on several topics. During the October meeting, we covered lessons learned from reopening and the addition of the work sample review to the Qualitative Site Review (QSR) process. During the spring meeting, we covered the revisions to the accountability framework and the transitional goals data collection related to COVID-19 impact. In addition, Lt. Anthony Guice from the Metropolitan Police Department provided an update on the future of the School Resource Officers Program, and a DC PCSB health consultant led a discussion on strategies and best practices for the 2022 - 23 school year. Charter school leaders were also afforded the opportunity to participate in breakout sessions by grade band to discuss strategies around PARCC testing, attendance, and other charter school issues.

Working in Communities

Annually, DC PCSB sets a goal to attend various community meetings and events throughout the year to hear from residents and other stakeholders.

To support schools and families, DC PCSB co-hosted multiple COVID vaccine education sessions with Children's National Hospital and public charter schools to educate families about the vaccine. In June 2022, DC PCSB participated in the COVID Vaccine Clinic at Friendship PCS Arts Festival. This community effort was aimed at getting children ages five and up vaccinated against COVID-19.

EdFEST 2021

In December 2021, DC PCSB participated in all virtual EdFest 2021 to help students and families explore the city's traditional and public charter school options for PK through grade 12. Many participants asked DC PCSB questions about public charter schools during the event, which was well attended.

ANC Conversations

Washington, DC, has Advisory Neighborhood Commissions (ANCs) that are nonpartisan, elected members representing 2,000 constituents by law. ANCs are the "voice of the community" and bring the government closer to the people. DC PCSB developed an engagement plan to deeply engage ANCs in our work and connect ANCs with their local public charter schools. In the 2022 – 23 school year, DC PCSB leadership and staff plan to present at several ANC monthly meetings to determine how we could best work together to serve the educational needs of all students.

Citywide Focus Groups and Survey

To inform DC PCSB's new charter application process, DC PCSB embarked on a comprehensive initiative soliciting feedback from District residents, including caretakers, educators, adult learners, and other stakeholders, to better assess community needs in education. We conducted high-level interviews of key stakeholders, held several focus groups in English, Spanish, and Amharic, and distributed a comprehensive survey in those respective languages that garnered more than 1,500 respondents. This work will inform our charter application and expansion revisions in the coming year.

Working with Government Agencies

In conjunction with with the DC Office of the State Superintendent of Education, DC PCSB shared guidance on virtual learning for the 2022 – 23 school year. We released a virtual program amendment application for schools that sought to offer a distance learning program on a regular basis.
