THE BOND ISSUE AND FACE AMOUNT WERE BOTH FOR A TOTAL OF \$3,535,000 AND A TERM OF SEVENTEEN (17) YEARS WITH MATURITY ON DECEMBER 1, 2027, AND WERE SOLD TO THE MANUFACTURERS AND TRADERS TRUST COMPANY, THE PROCEEDS OF WHICH WERE LOANED TO THE CHARTER SCHOOL BY THE DISTRICT OF COLUMBIA GOVERNMENT PURSUANT TO SECTION 490 OF THE DISTRICT OF COLUMBIA HOME RULE ACT. THE BOND PROCEEDS WERE USED TO FINANCE BUILDING IMPROVEMENTS AND RELATED CAPITAL EXPENDITURES AT 138 12TH STREET, NE, WASHINGTON, DC (LINCOLN PARK), AND AT 2015-2017 SAVANNAH TERRACE, SE, WASHINGTON, DC (DOUGLAS KNOLL), AS WELL AS TO PAY FOR CERTAIN BOND ISSUANCE COSTS.

THE INTEREST RATE ON THE BONDS WAS DETERMINED BY TAKING THE SUM OF THE PURCHASERS (M & T BANK) FIVE-YEAR COST OF FUNDS RATE, PLUS 3.50%, LESS THE TAX CREDIT RATE OF 5.37%, RESULTING IN A ZERO (0%) INTEREST RATE TO THE CHARTER SCHOOL. THE BONDS HAVE THREE SCHEDULED CALL DATES OF DECEMBER 1, 2015, 2020, AND 2025.

THE LOAN AGREEMENT CONTAINS CERTAIN RESTRICTED, FINANCIAL, AND NONFINANCIAL COVENANTS.

THE BOND OBLIGATION IS ALSO GUARANTEED BY THE APPLETREE INSTITUTE FOR EDUCATION INNOVATION THROUGH A SENIOR DEED OF TRUST, ASSIGNMENT AND SECURITY AGREEMENT RELATING TO THE TRACT OF LAND TOGETHER WITH IMPROVEMENTS LOCATED AT 138 12TH STREET, NE, WASHINGTON, DC. THE INSTITUTE IS REQUIRED TO MEET CERTAIN DEBT SERVICE COVERAGE RATIOS AS MEASURED ON AN ANNUAL BASIS.

BECAUSE OF A DELAY WITH THE DISTRICT'S PROGRAM AUDITS, DURING THE YEAR ENDED JUNE 30, 2020, THREE SEPARATE PAYMENTS WERE RECEIVED REPRESENTING THE THREE PREVIOUS YEARS COST REIMBURSEMENTS IN A TOTAL AMOUNT OF \$230,003
